REGULATION "BARDOLINO T-EXPO 2022"

Art.1) – ORGANIZER

Organizer and sole manager of the exhibition village called "**Bardolino T-EXPO 2022**" is the sports group A.S.D. G.S. Bardolino, based in Bardolino (VR) in Via G. Marconi n ° 19, which provides to appoint a manager for the direct and complete management of the initiative.

Art. 2) - PROGRAMME

The aforementioned initiative will take place on the days and times provided for in the following official program that the exhibitor undertakes to scrupulously respect. For no reason it is possible to grant derogations and / or extensions to these times.

- **Friday, June 10, 2022:**
 - from 11.00 am: start of the exhibition area;
 - from 13.00 to 22.00: preparation and opening to the public of the exhibition stands.
- **Saturday 11 June 2022:**
 - from 08.00 to 19.00: opening to the public "Bardolino T-Expo 2022";
 - from 19.00 to 20.00: dismantling of all exhibition spaces.

Art. 3) – APPLICATION FORM

The application for membership must be sent by email to the following address: gigi.beriti60@gmail.com using only the form prepared (see Sec. B), duly completed, stamped and signed in all its parts. The exhibitors' request will be confirmed by the organizer by sending an email within 7 days of receipt of the printed aforementioned document. The admission fee refers to the exhibition area in the measures in front width and lateral length indicated in the application form. For reasons of space only, max. n° 5 stands with a front width of 6 (six) meters will be admitted. The disposal of waste and packaging is the responsibility of the exhibitor and the occupied surface must be left cleaned and free from any material after the dismantling of the stand.

Art. 4) – METHODS AND TERMS OF PAYMENT

The payment must be made in advance, no later than 31.05.2022, by bank transfer, using the bank details and the reason indicated in the application form (see Sec. B).

For each payment, a special electronic invoice will be issued by the organizer.

Art. 5) – ALLOCATION OF EXHIBITION SPACES

The assignment of the exhibition spaces to the individual stands is carried out according to the chronological order of payment, with simultaneous receipt of the application form and with priority to exhibitors with greater seniority of presence, considering that the available spaces are limited. All the admitted stands will be assigned a number to be exhibited, which can be consulted in the planimetric map sent a few days before the event. Any stands of the official sponsors will be assigned with absolute priority in the reserved area adjacent to the change area and / or expressly chosen by them.

It is not allowed, for reasons of space, the direct exposure of associations, sports clubs, groups, etc. which, however, can be hosted, by prior arrangement, inside and / or on the space behind the stands regularly admitted. The organizer reserves the right to reject and / or provisionally accept requests for membership.

Any claims for damages will be accepted and evaluated at the discretion of the organizer.

Art. 6) – RIGHT OF WITHDRAWAL

Withdrawal from this contract is only possible in the event that the booked exhibition space can be reused by another exhibitor. For withdrawals and / or waivers received after the peremptory date of 05 June 2022, no refund will be recognized in case of advance payment. The exhibitor is not allowed to sell his exhibition space without having received the explicit authorization of the organizer.

Art. 7) – EXHIBITION AREA MANAGEMENT

The interior decoration of the exhibition space is the responsibility of the exhibitor, while the connection to the electricity grid must be explicitly requested and indicated in the application form. It is necessary to have your own tensile structures and / or provide for the rental of the same. The power supply comes free of charge from the special fixed electrical panels located in the exhibition area with a 360-volt socket.

In case of electricity supply, equip yourself with an adequate extension cable (at least 20/30 mt.). The surface of the assigned exhibition space can only be used inside and / or outside for any advertising billboards.

The stands will be controlled and managed by the organizer during the set-up phase.

*In the **T-Expo** area it is allowed the permanent parking of only 1 vehicle per single stand for the entire duration of the exhibition activity, subject to a special authorization pass (with the license plate of the authorized vehicle) to be displayed clearly visible on the vehicle and issued by the person in charge upon arrival.*

The exhibition stands must absolutely not occupy the asphalt pedestrian area of the Cornicello lakefront on the day of the race, but rather remain within the green area specially delimited by a gray concrete curb. The parking area is free of charge and located on the dirt road behind the exhibition area.

Each exhibitor will be given n ° 2 free meal vouchers to be consumed exclusively at the final refreshment / pasta party.

Each exhibitor must fill in a special form prepared by the organizer and containing the declaration of conformity of the structure.

The free security and night surveillance service is provided and will work with the fixed presence of No. 2 appointees from 22.00 on 10.06.2022 to 8.00 on 11.06.2022.

Art. 8) – EXCLUSIVITY

The exclusion of commercial competition can NOT be guaranteed and if present, must be accepted by all exhibitors.

Art. 9) – LIABILITY

*Each exhibitor must be in possession of a special insurance coverage for goods and materials destined for **the BARDOLINO T-EXPO**. All consequences arising from the lack of insurance coverage are borne by the exhibitor. The organizer is not liable for damage caused by third parties to the exhibition space, as well as for the theft of goods and / or goods belonging to the exhibitor.*

If, due to the violation of contractual obligations by the exhibitor, the organizer is liable for pecuniary penalties (fines, various sanctions, compensation for damages, etc.), the same will be charged to the exhibitor himself.

Art. 10) – FORCE MAJEURE

*The organizer may, for valid and binding reasons (e.g., modification/revocation of membership) or in the event of serious force majeure, exercise the right to postpone, reduce, temporarily close or permanently cancel the **T-Expo 2022**.*

In such cases, exhibitors may request a full and/or partial refund of the membership fee, subject to a precise agreement with the organizer who reserves any decision on the matter.

Art. 11) – DISPUTES

*For disputes that may occur related to the "**Bardolino T-Expo 2022**", the Italian legislation in force on the subject is considered valid. The competent court is that of Verona.*
